Objective and Investment Policy

The objective of this Sub-Fund is to track the performance of Bloomberg China Treasury + Policy Bank Index, and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The Sub-Fund aims to achieve a level of tracking error of the Sub-Fund and its index that will not normally exceed 1%. The Index is a Total Return Index : the coupons paid by the Index constituents are included in the index return. Bloomberg China Treasury + Policy Bank Index is a bond index representative of CNY-denominated fixed rate Treasury and Policy Bank securities listed on the China Interbank market. 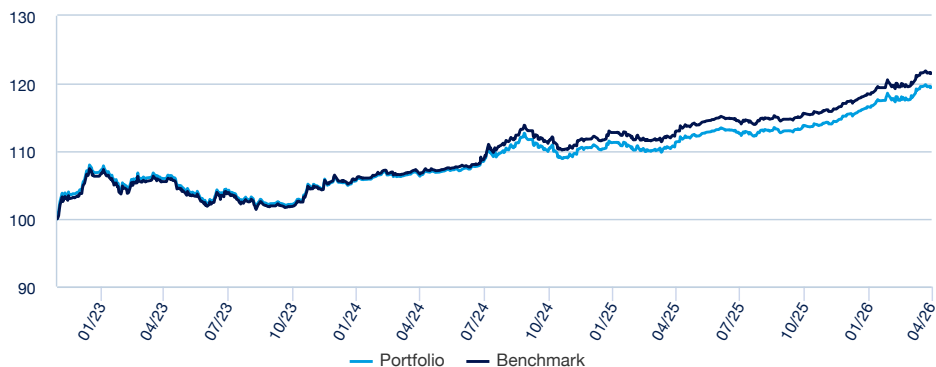

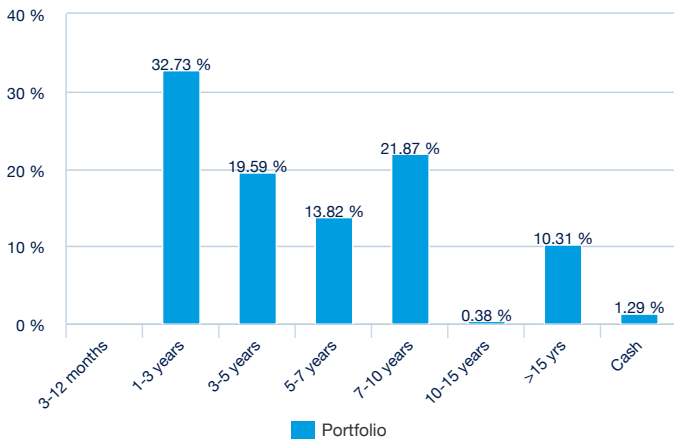

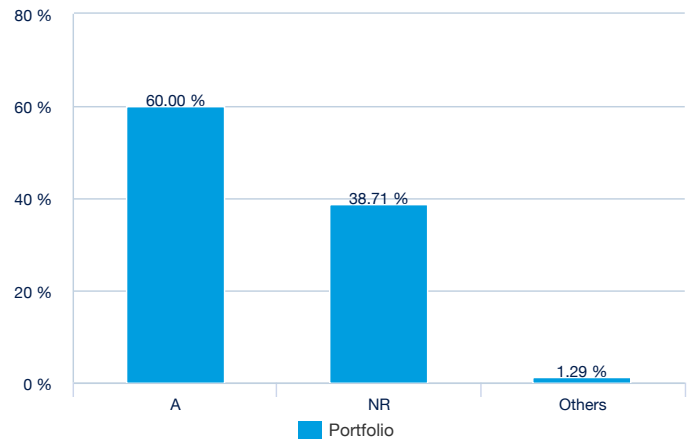

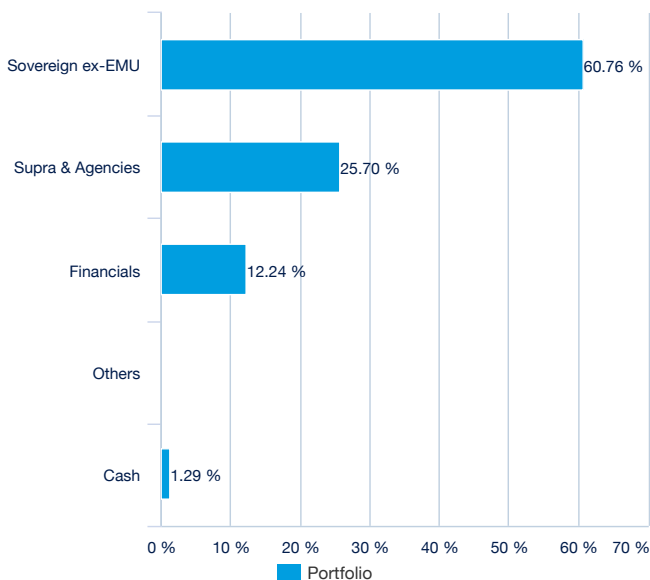
By maturity (Source: Amundi)



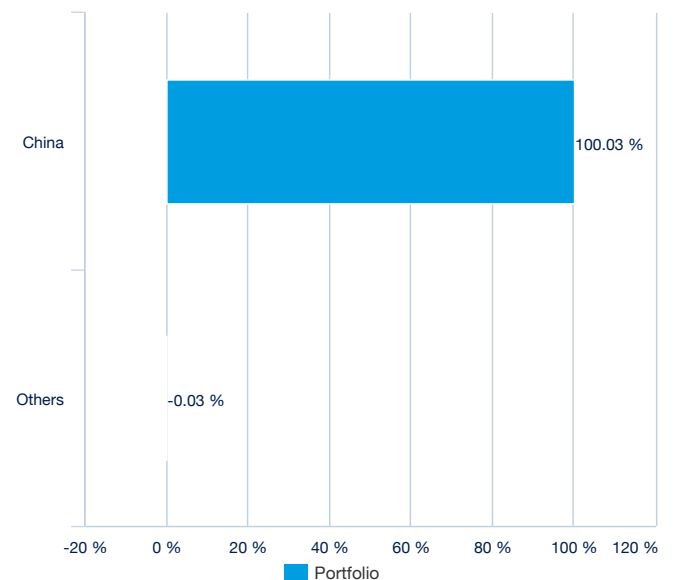
