## Amendment to the Prospectus of the Company in relation to the Sub-Funds

We hereby inform you that the following change, as described in the present notice, will be effective at the **opening of 1. Juni 2023** (the "**Effective Date**") in relation to the Sub-Funds.

Hence, from the Effective Date:

## Change of the maximum anticipated level of the tracking error for the Sub-Funds

The Board of Directors and the Management Company have decided to modify the maximum anticipated level of the tracking error ("**TE**") under normal market conditions expected for the Sub-Funds (the "**Modification**") as follows:

Sub-Fund	Previous anticipated level of TE of the Sub-Fund	New anticipated level of TE of the Sub-Fund
Lyxor DAX (DR) UCITS ETF	0.20%	1%
Lyxor DAILY LevDAX UCITS ETF	0.40%	1%
LYXOR HONG KONG (HSI) UCITS ETF	0.50%	2%

Those changes intend to simplify the understanding of our range and to harmonise the maximum anticipated tracking error levels for the Sub-Funds offering similar exposure.

Please note that no change in the <u>effective level</u> of tracking error is expected under normal market conditions in connection with this modification.

Importantly the Modification does not represent a change of the investment objective nor the investment policy of the Sub-Funds. The other characteristics of the Sub-Funds remain unchanged.

Following the implementation of this modification, the Prospectus will be amended accordingly.
