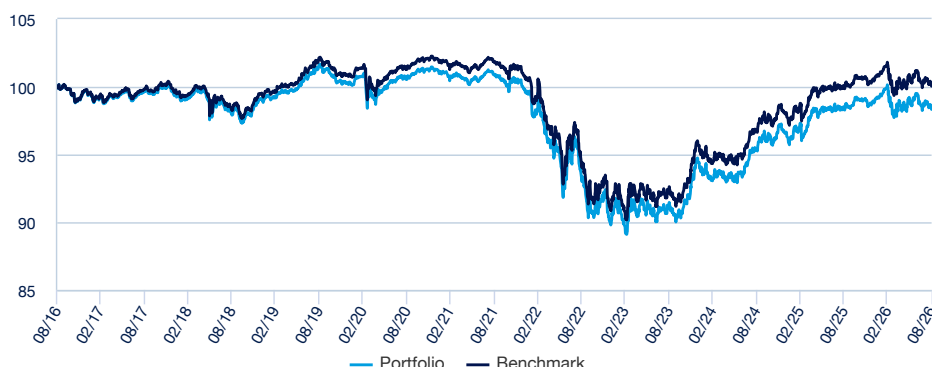

## Description of the Index

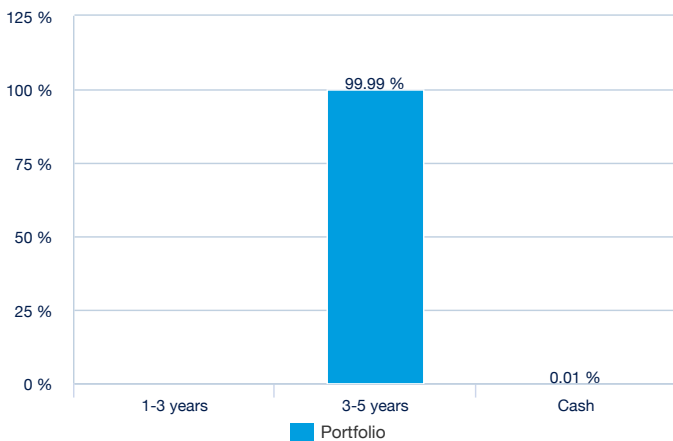

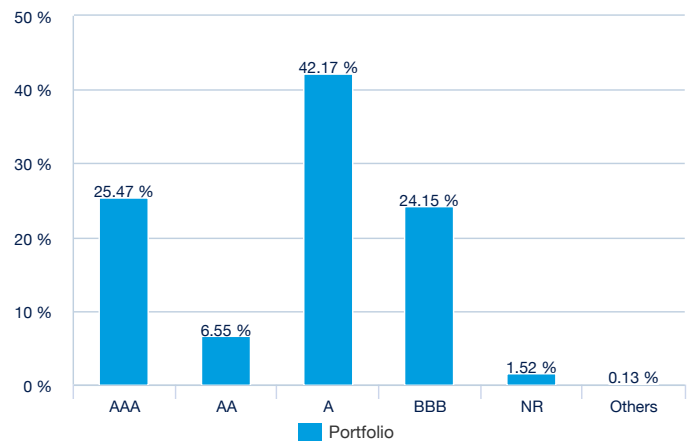

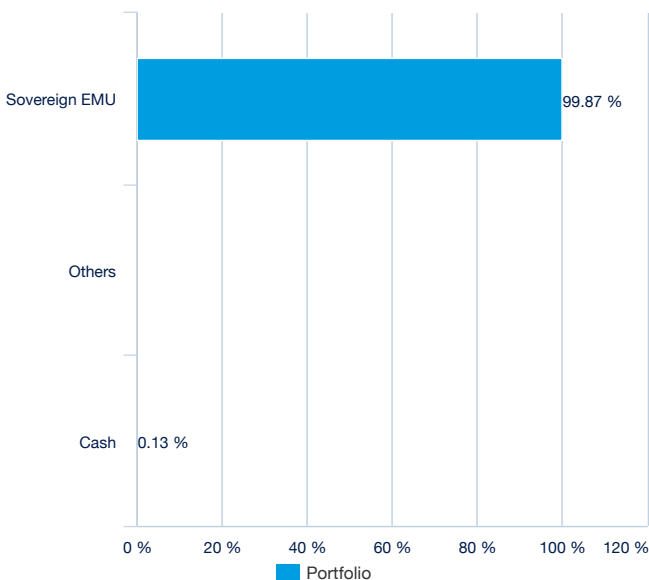
### By maturity (Source: Amundi)



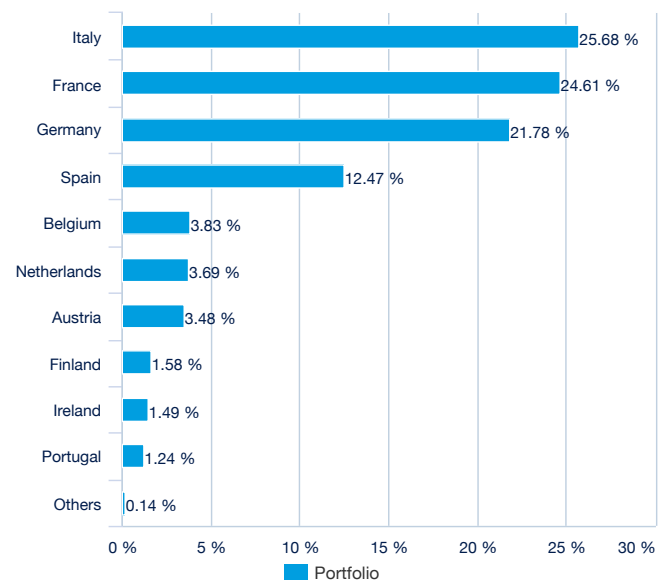
