Objective and Investment Policy

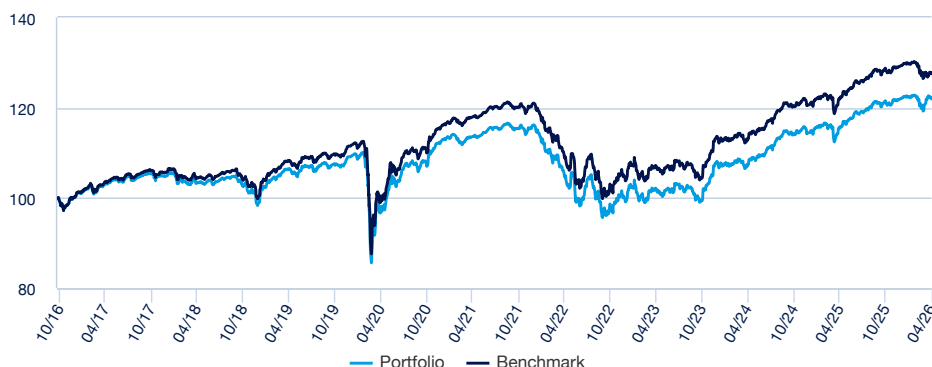

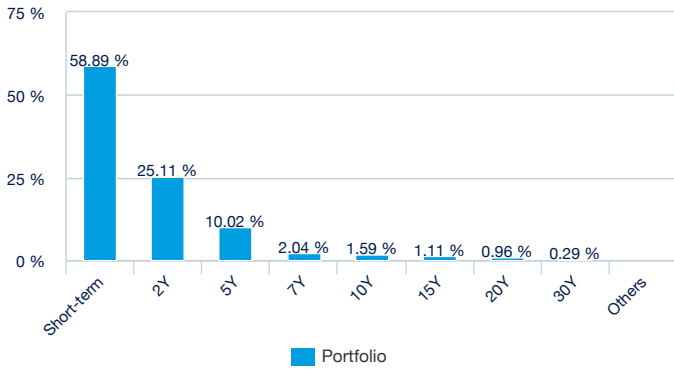

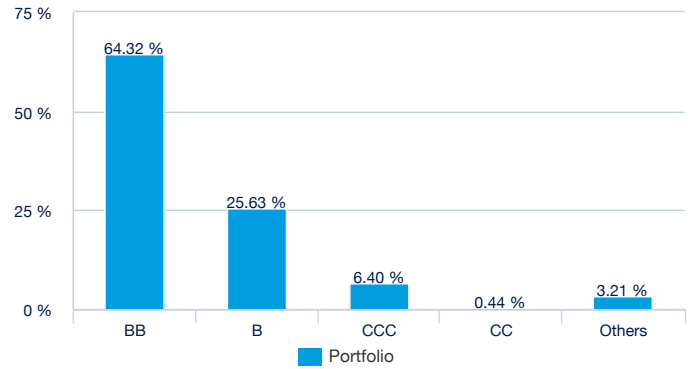

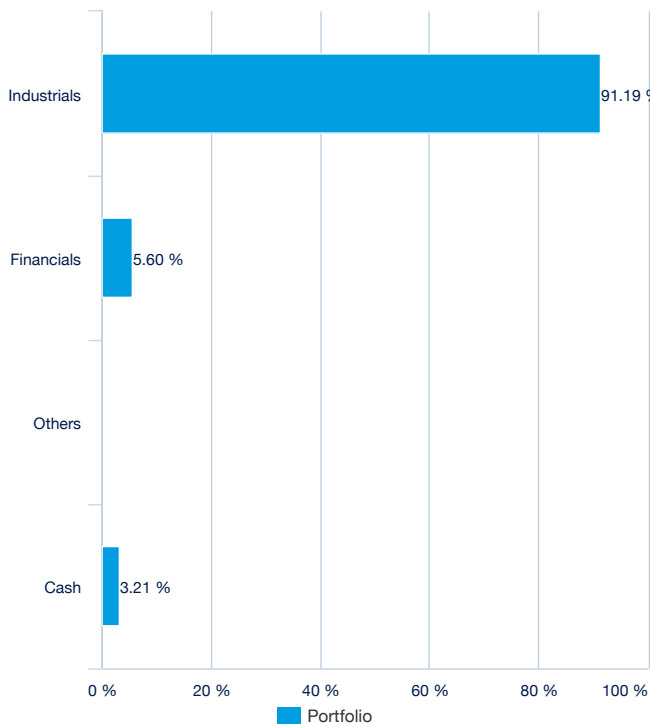

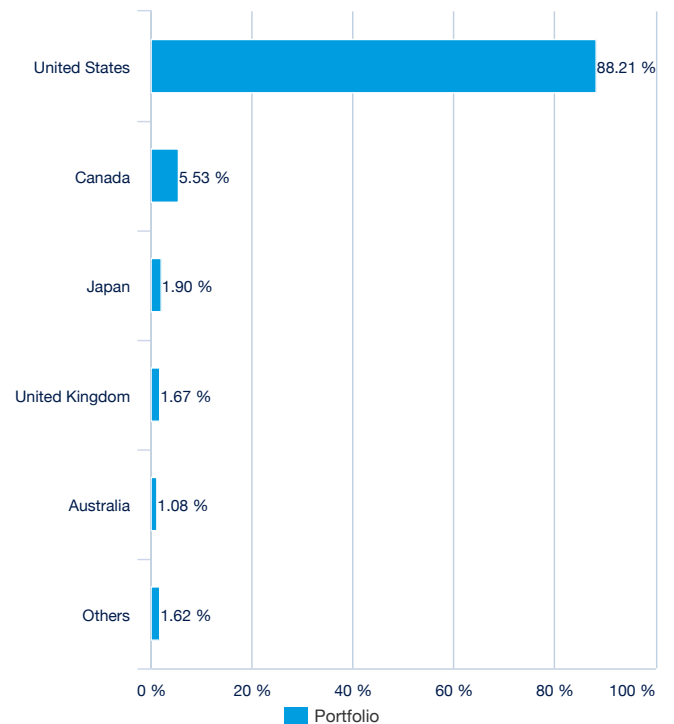
