What is this product?

Type: Shares of a Sub-Fund of Amundi Index Solutions, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: This Sub-Fund is passively managed. The objective of this Sub-Fund is to track the performance of SHORTDAX Index, and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The Sub-Fund aims to achieve a level of tracking error of the Sub-Fund and its index that will not normally exceed 1%.

The Index, which is calculated by STOXX Ltd., is tied to the performance of the German blue chip DAX® index (Performance Index) (the "Base Index") and tracks at index level the performance of an investment with a short position in relation to the DAX® Index. The DAX® Index calculated by STOXX Ltd. comprises the 40 largest German companies with the highest turnovers that are listed on the Frankfurt Stock Exchange. The Index is a Total Return Index : the coupons paid by the Index constituents are included in the index return. More information about the composition of the index and its operating rules are available in the prospectus and at: stxx.com The Index value is available via Bloomberg (SHORTDAX).

The Sub-Fund will apply an Indirect Replication methodology to get exposition to the Index. The Sub-Fund will invest into a total return swap (financial derivative instrument) delivering the performance of the Index against the performance of the assets held. Derivatives are integral to the Sub-Fund's investment strategies.

The Sub-Fund's shares are listed and traded on one or more stock

exchanges. In normal circumstances, you may deal in shares during the trading hours of the stock exchanges, provided that the Market Makers can maintain market liquidity. Only authorised participants (e.g. selected financial institutions) may deal in shares directly with the Sub-Fund on the primary market. Further details are provided in the prospectus of the UCITS.

Intended Retail Investor: This product is intended for investors, with a basic knowledge of and no or limited experience of investing in funds seeking to increase the value of their investment over the recommended holding period and who are prepared to take on a high level of risk to their original capital.

Redemption and Dealing: The Sub-Fund's shares are listed and traded on one or more stock exchanges. In normal circumstances, you may deal in shares during the trading hours of the stock exchanges. Only authorised participants (e.g., selected financial institutions) may deal in shares directly with the Sub-Fund on the primary market. Further details are provided in the Amundi Index Solutions prospectus.

Distribution policy: The Fund's amounts available for distribution (if any) will be distributed.

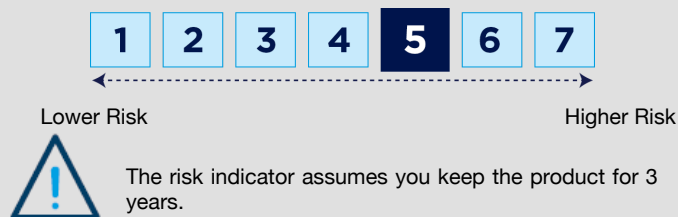

What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movement in the markets or because we are not able to pay you.

What happens if Amundi Luxembourg S.A. is unable to pay out?

The assets and liabilities of the Sub-Fund are segregated from those of other sub-funds as well as from those of the Management Company, and there is no cross-liability among any of them. The Sub-Fund would not be liable if the Management Company or any delegated service provider were to fail or default.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years is based on our assessment of the risk and reward characteristics and costs of the Sub-Fund.

Order schedule: Orders to redeem shares must be received before 05:00 PM Luxembourg time on the Valuation Day. Please refer to the Amundi Index Solutions Prospectus for further details regarding redemptions.

This product is designed for medium-term investment; you should be prepared to stay invested for at least 3 years. You can redeem your investment at any time, or hold the investment longer.
